Legislative Report:

- The house passed SB89, the Educational Choice Scholarship Program bill. The bill is now sent to the senate for a vote this week. The Senate is expected to refuse to concur with the House's changes. If that happens, a conference committee will need to be convened to reconcile the differences.
- The Senate passed SB134. The bill increases the penalties for the offense of improperly passing a stopped school bus, allows images captured by school bus cameras to be used as corroborating evidence for such an offense and appropriates \$500,000 for fiscal years 2020 and 2021 for purchasing and installing cameras on school buses. The bill now goes to the House.
- The House Health Committee held a second hearing on HB 243, which requires that all health benefit
 plans, including those provided by school districts, provide coverage for the full cost of up to \$2,500
 per hearing aid for each hearing-impaired ear every 48 months for a covered person under 22 years of
 age and all related services.

Vantage Career Center Report:

- Over 900 students attended Vantage's Sophomore Day
 - 2 new programs are being added next year:
 - Sports Exercise Therapy, and
 - Transition to Work for IEP Students

Discussions during the Superintendent's report (in schoology):

- Mr. Lammers met with First Responders and will hold the Annual Safety Drill on gas leaks on March 30th.
- The process to hire a science teacher, replacing Ken Pothast, has begun.
- The details have been worked out and we will be signing an amendment to our 2008 elementary building lease agreement with the Diocese of Toledo to include the "A" diamond as part of the leased premises.
- We are looking at the possibility of installing a new serving line in the elementary café.
