Money received to operate school districts is assigned to the following funds: general, set-a-side, debt service, permanent improvement, cafeteria, student activity funds, athletic, and state and federal grants. These funds are established by law to help ensure that money is spent for the intended purpose for which it was raised.

The *General Fund* is used to account for all money used for ordinary operations of the school system except those required to be accounted for in another fund. Ordinary operations include salaries, fringe benefits, supplies and materials, and maintenance services.

Since 1998 every school system is required to have two 'set-a-side' funds. One fund is to be used for purchasing *instructional* materials and textbooks and the second is for *capital outlay and improvements*, defined as major purchases, repairs or improvements that should last five years or more. The law requires the district to 'set-aside' 3% of the general fund revenue into each of these funds for expenditure on the purpose stated.

The *Debt Service Fund* is used for the accumulation of money to be used for the payment of short-term and long-term debt, principal and interest. All revenue derived from bond issues, which are levied for debt payment, must be deposited into this fund. Funds received from the current building levy are deposited into this fund and can be used *only* to pay off the building project debt.

The *Permanent Improvement* fund is used to account for equipment purchases or capital improvements to our facilities. This might include a new roof, purchase of text-books or computer equipment, or school bus purchase.

All revenue derived from permanent improvement issues, which are levied for permanent improvements, must be deposited into this fund.

The *cafeteria fund* is used to record financial transactions related to the food service operations. This fund pays for salaries and benefits of the cafeteria staff, food and non-food supplies, and equipment used solely for cafeteria use. This fund is operated in a manner similar to private business enterprises where the intent is to cover operating expenses through charges to students and adults for lunch.

Student Managed Activity Funds are funds provided to account for those student activity programs which have student participation in the activity and have students involved in the management of the program. These funds are raised by students. Examples of these types of funds include class budgets, cheerleading, student council, and foreign language club funds.

The *Athletic Fund* is provided to account for athletic programs which have student participation, but do not have student management of the program. These funds are raised by the athletic department through ticket sales and donations.

Kalida Schools also have *State and Federal Grant Funds* used to account for revenue that is legally restricted to expenditures for specified purposes. Examples of these funds include Title I Funds that are used for afterschool tutoring, and *SchoolNet Funds* which are used to purchase computer equipment at various grade levels.

# **Food Service Inspection**

Every five years, the Ohio Department of Education holds a food operations inspection in one of the two buildings. On Thursday, March 11, regional consultant Mr. Ralph Kuenning came to Kalida and inspected the daily operation of the elementary cafeteria. During the day Mr. Kuenning met with Mr. Williams and Mrs. Grote and went over the monthly reports and the free and reduced lunch claims. He also met with the head cooks Mrs. Jan Schroeder and Mrs. Joyce Klausing.

At the conclusion and on his exit report Mr. Kuenning wrote, "The program is well organized and operated with high quality standards. The cafeteria staff is dedicated and treats their customers like family. I thank you and your staff for your time, cooperation and courtesies extended to me during the review. Keep up this great effort."

Mr. Williams added his commendations to the staff for their outstanding work. "It is gratifying to know that our cafeteria operation meets all standards set by the state. # **Reaching Out Across the Seas**

The Kalida High School students have been busy writing to Chinese pen pals. Four language arts classes are involved including the seventh and eighth grades and the freshmen and sophomores. This project started last year when the current eighth grade class was matched with a teacher and class at *Linquan Second Middle School*, Anhui, China. They were matched with this teacher and class through *The Lima News* Newspaper in Education pen pal project. Currently, 57 seventh graders now write to 207 Chinese students while the eighth graders write to 64 pen pals and the freshmen and sophomore students write to 230 Chinese students.

There are so many benefits that are gained through this project. First, the students are practicing letter writing which seems to be a dying art in the technology driven world today. Secondly, they are learning valuable lessons in cultural diversity. The students enjoy learning about the Chinese culture from their pen pals and love sharing their American traditions. Students spend time taking virtual field trips to China using Internet sites to look at pictures of the country and read about China and Anhui.

Mrs. Pam Schroeder has developed a website for this activity at <a href="www.kalida.k12.oh.us/staff/pamschroeder/china.html">www.kalida.k12.oh.us/staff/pamschroeder/china.html</a>. Anyone can access the website at school or at home. Many writing assignments are now geared

towards our Chinese pen pals. By using the pen pals as an audience, students are given a larger purpose and it becomes a natural motivator for the students in their writing assignments.
