A lot of planning goes into beginning a new school year and as early as last May, teachers met their next group of students and started the learning cycle in motion. Wrinkles have been ironed out of bus routes and schedules and the end of the first quarter is upon us already. I'd like to commend everyone for getting the school year off to a great start. District finances are in solid shape. The school board met on August 27 to study our district financial picture. A combination of reliable returns from our local income tax, the fact that state funding is holding steady and a new three year contract was finalized with our employees starting August 1, has allowed the school board to take the initiative to pay off the 2009 elementary building bonds early. As a result of wiping off that debt, we can then refinance the 2003 high school building bonds, saving the district tax payers a considerable amount of money through 2031. Later in this edition, you will see an increase in student lunch prices. Higher prices are mandated to offset ever-rising food costs, particularly those associated with the federal Healthy Hunger Kids Act of 2010 designed to provide healthier options for students.

KALIDA HIGH SCHOOL TO USE ACT ASPIRE

Beginning with the Class of 2018 (the current freshman class), the requirements for graduation will be considerably different than they were for the classes ahead of them in school. One thing that has not changed are the course requirements that all students must complete to earn a diploma. Four units each in English and Math, three units each in Science and Social Studies, health and physical education, financial literacy, fine arts and electives to total 21 credits must be earned to be eligible for graduation.

The most significant changes in the pathway to graduation lies in the testing requirements of the Ohio Department of Education. Passing the five parts of the Ohio Graduation Test (OGT) has been a requirement for our students to graduate from high school beginning with the Class of 2006. The OGT has been replaced with a series of End-of-Course Exams. The class of 2018 will need to take End-of-Course Exams in Algebra I, Physical Science, English I this year, and American History, Geometry, English II, and American Government in the years to come.

Students may also warrant their diploma by earning a "remediation-free" score on a college admission exam such as the American College Test (ACT). The State of Ohio will provide one free administration of the ACT to the Class of 2018 during their junior year of high school. To help these students perform their best on the ACT, we have committed to participating in the ACT Aspire program later this month.

The ACT Explore and ACT Plan tests have been used the last several years by Kalida High School to help prepare student to take the ACT as a junior or senior. The Explore Assessment has been given to all freshmen while the Plan has been administered to all sophomores. KHS is planning on continuing student preparation for the ACT by taking part in the Aspire Program which is replacing the Plan and Explore assessments. ACT Aspire Early High School (grades 9–10) provides a predicted ACT score range for each subject area and a composite score. It also allows 9th and 10th graders to determine if they are on target for college readiness as they prepare to take the ACT test and engage in college planning. The Aspire assessments will be administered online which will also help prepare our students for this method of testing which will be used for the new statewide assessments (End-of-Course Exams). It is also believed that the ACT will be administered online within the next few years.




Mrs. Scherer Earns Certification
