Mr. von der Embse motioned to approve the following teachers as 2012-13 after school tutors:

Mrs. Gerdeman seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

Mr. von der Embse asked the administration to remind coaches/staff that emails/phone calls from parents should be accepted, that they do not have to come from the athlete/student. Mr. Pfahler said this is the preferred method and would remind all staff.

Mr. von der Embse also said a parent questioned our drinking water quality in the high school, stating students thought it was different from the elementary. Mr. Horstman informed the board that town water, which is tested annually by the Village, is fed to both schools and that the school is inspected by the health department twice a year.

Mr. Turnwald asked the high school principal to stress the importance of students taking the PSAT and ACT tests, and taking them seriously. Often they don't realize the financial reward that can come with these results until it is too late. Mr. Pfahler stated they do meet with the sophomores about this, and did have an announcement about the PSAT on the announcements all this week.

Mr. Turnwald, along with other board members, also wanted to pass along 'kudos' to the new district cafeteria manager and the entire cafeteria staff in both buildings as they have been receiving many compliments about the new foods being served.
