## **Notes from the Superintendent**

It has been a very interesting winter so far, and we still have a ways to go. As of mid January, the district has used five calamity days due to every kind of weather imaginable. Since the start of the new year, we have experienced ice, snow, fog, and high water. Ironically enough, to date I have received no complaints from students. As a newcomer to the district, I am very impressed at the number of parents who were able to get their children to school on days when the water was too high to send a bus down their roads. Our district-wide attendance was actually very good on those days. Thank you all for your patience and cooperation as we continue to make our way through the winter season.

The construction project is steadily moving forward. The masons are currently laying up the interior walls and the interior is beginning to take shape. The gymnasium floors have been poured and a great deal of the rough plumbing and mechanical work is complete.

The district will be holding two community meetings (January 31 and on February 2) to discuss our options in terms of school finance. I strongly encourage everyone to attend. I have heard several opinions expressed about the district's financial situation. I want you to know that I appreciate those of you that have taken an interest. The purpose of this meeting is to provide factual information to district residents and to solicit your input on the direction we should take.

School finance is a very complex subject due to the fact that every district in the state has different needs. The state has come up with one very convoluted formula and attempted to meet the needs of 612 very different districts. We will specifically be discussing the effects of property tax, income tax, tax abatements, and new construction, on district finances. Additionally, I will be presenting some vital statistics in terms of health care cost, decreased enrollment, and decreased state funding. Our treasurer, Cindy Webken, will be giving a brief synopsis of our five-year financial forecast and attempt to explain the ramifications and long term effects of deficit spending. This forecast is available on the school website (http://kalida.k12.oh.us) and I certainly encourage all residents to take a look at the numbers.

While all the speculation pertaining to school finance is typically not good news, we do have some very viable options in terms of how we approach the issue. The bottom line is that the Kalida Local Schools provide a wonderful education to the children of Kalida. Incidentally, we are able to do this for less money than 599 of the 612 districts in the state. Virtually every school district in the state either already has, or is in the process of, asking for new money. My goal, and that of the school board, is to keep you informed throughout the entire process.

### **Today's Educational Technology**

With more and more projects integrating technology into the curriculum and the classroom, students are finding a bigger and greater need to transfer information they have found over the Internet or other applications from home to school and vice versa. Many students have been using diskettes, an older technology, to transfer this information. A diskette's life expectancy is a year or two at longest and that includes shelf life. Many students bring in diskettes with information saved that we end up not being able to retrieve because of damaged resources.

There are several ways to more effectively transfer information today. A product known as a USB micro hard drive (or commonly called a FLASH drive) is available in various sizes from retailers like OfficeMax and even

Wal-Mart and simply plugs into a USB port of your computer and acts just like another hard drive on your machine. These are cross-platform devices so they will work on the latest Windows Operating Systems (2000, XP) as well as Macintosh environ-



ments. By watching the sale ads, you may even get these



devices free after mail-in rebate. The bigger the drive size (usually in MB- remembering that 1MB = approximately 1 diskette) allows for files with different types of media which we are using in today's applications such as Powerpoint.

Another way is to transfer information is with a live Internet
